RE's Report

No club races have transpired since my April article, however we've had a number of Solo events thanks to our Cape Fear Chapter. I'm sure Richard Franklin and others will cover those events in depth. There was also a rally held on April 14 with coverage on page 9.

Looks like the competition season is in full swing and many of us, including myself, are in the midst of prepping ourselves and our cars for the upcoming SARRC/MARRS race Mother's day weekend. Based on the large number of drivers already pre-registered, this could be one of our largest events. It appears that our decision to drop this from a 3-day event to a 2-day event was preferred by most drivers. If you have never competed in this particular event, you may want to think about it before the late fees kick in. Even if you don't compete, you should really consider coming out to spectate. Fields are typically large and competition tight. Looks like the Spec Miata race may have over 60 competitors in both Saturday and Sunday's races! Talk about excitement!

On a less upbeat note, I am very disappointed to report that the Region decided to cancel our April PDX (high performance driving event or HPDE) slated for Rockingham due to a very low turnout. This was a difficult decision for the Board of Directors (BOD) as there were a number of excited drivers really looking forward to this event. Also, this is the second time we have had to cancel an event at Rockingham due to limited response (our Club Racing School last year was the other) and the Region is very concerned that a pattern of cancellations could jeopardize our club's status at this venue. Since we also had a light turnout for last year's PDX, the Board had a long discussion regarding the future of PDX type events. While there was some consideration of abandoning PDX events all together, the final decision was to host our proposed September PDX as planned. However, this event is a "do or die" for the PDX program. If

What's In Your Shop?

We all love tools. What's your favorite?

it succeeds and we have a good turnout then the region will put on more of these events. If the turnout is poor, then the BOD will likely pull the plug on the program. Consequently, we need everyone in the region to do everything possible to encourage folks to sign up for this event. Remember, these events are open to essentially anyone who has a valid drivers license, so encourage your friends, relatives, anyone you can think of who likes to drive to come on out. I have never heard of anyone who did not have a great time and there is no better value of car or track time for the money. In fact, I believe that NCR's events are the lowest priced PDX events available.

As part of the BOD's decision to move forward with the PDX, it was decided to not include any races that weekend so that the region could focus on the PDX. As a result, the tentative double Carolina Cup Pro Series (CCPS) races will not be held that weekend. However, it appears likely that CCR's Lowe's event may turn into a double CCPS weekend as an alternative. This would allow the series to host 2 double weekends this year with the other being NCR's Oak Tree National weekend in August.

In other CCPS news, the Budget and Finance Committee recommended that we discuss either increasing the CCPS entry fees or reducing the amount that goes back into that series since the revenue per competitor in that series is low (\$75 of the entry fee goes back to the CCPS series for prize money and administration).

In SEDIV news, it appears that spec tires will be a big issue at the upcoming Mid-year meeting in July. My understanding is that "ballots" are floating somewhere in cyber

space in regard to both IT7 and Spec Miata (if you can't find them, check with Blair Stitt or contact the SEDiv Chief of Tech, Toni Creighton. If you race in those series, or even if you simply prep cars for those series, it appears you are eligible to vote. So take this opportunity to let your preference be known. As RE, I will also be polling the drivers in these classes prior to the meeting so I can vote for what our drivers prefer.

Once again, it's the time for my monthly plea for volunteers to help in a few areas. We desperately need assistance in the Sound Control Specialty. This is a relatively easy specialty and we would like to line up a number of staff so that we can rotate volunteers. We are also looking for F&C workers and other volunteers to help with the next (and hopefully not our last) PDX at Rockingham September 8-9. This is a relatively low-key event so it's a great opportunity for someone who would like to learn how to work a corner.

Also, our current Banquet Committee will continue to organize the annual event in Raleigh if that is acceptable to the membership. However, the Board of Directors would support moving it to another location if members from that location are willing to step up and take over the responsibilities of the Banquet Committee.

One last item, I announced at the last BOD meeting that I do not intend to run for re-election so this will be my last year as your RE. That means the Region will be looking for someone to take over this very important position within the organization.

As always, I hope to see all of you at one (or all!) of these events. 🍀

- every two (2) years for those 50-59 years of age
- every year for those 60 years of age and older

I'm glad that I got to participate in this event since our next scheduled event, the PDX, had to be cancelled due to lack of participants.

One of the questions we are faced with as Board members: is there a need for the PDX type events? The lack of participants could be interpreted as evidence that our PDX is not wanted or needed. However, a few years ago it was suggested to the Board that our Region needed an event that would teach car driving skills, which is one facet of a PDX.

Or could it be that we haven't marketed the event correctly to our membership and to "civilians"? Do our members know what the function of a PDX is? That they

can bring their street car, showroom stock or improved touring race car to participate? That they don't need a competition license, or even an SCCA membership to participate?

There was supposed to be a Club Trial event also, which is more or less a Solo I event: you drive on the track racing the clock, and any street or racecar is eligible. Can you say cheap track time? Or test day?

We realize other organizations have PDX type events, with waiting lists for some of them. What are we doing wrong?

This was extensively discussed in our last Board meeting. We realize that no one on the Board is necessarily a marketing major. Nor do we have an operable crystal ball. And a Magic 8 ball is a poor substitute.

While we have ideas, we don't have all the answers. Since there are about a thousand members in the North Carolina Region, maybe some of you have some answers or ideas that we need to hear?

10. EIGHT-FOOT LONG DOUGLAS FIR 4X4: Used to attempt to lever an automobile upward off a hydraulic jack handle.

11. TWEEZERS: A tool for removing splinters of wood, especially Douglas fir.

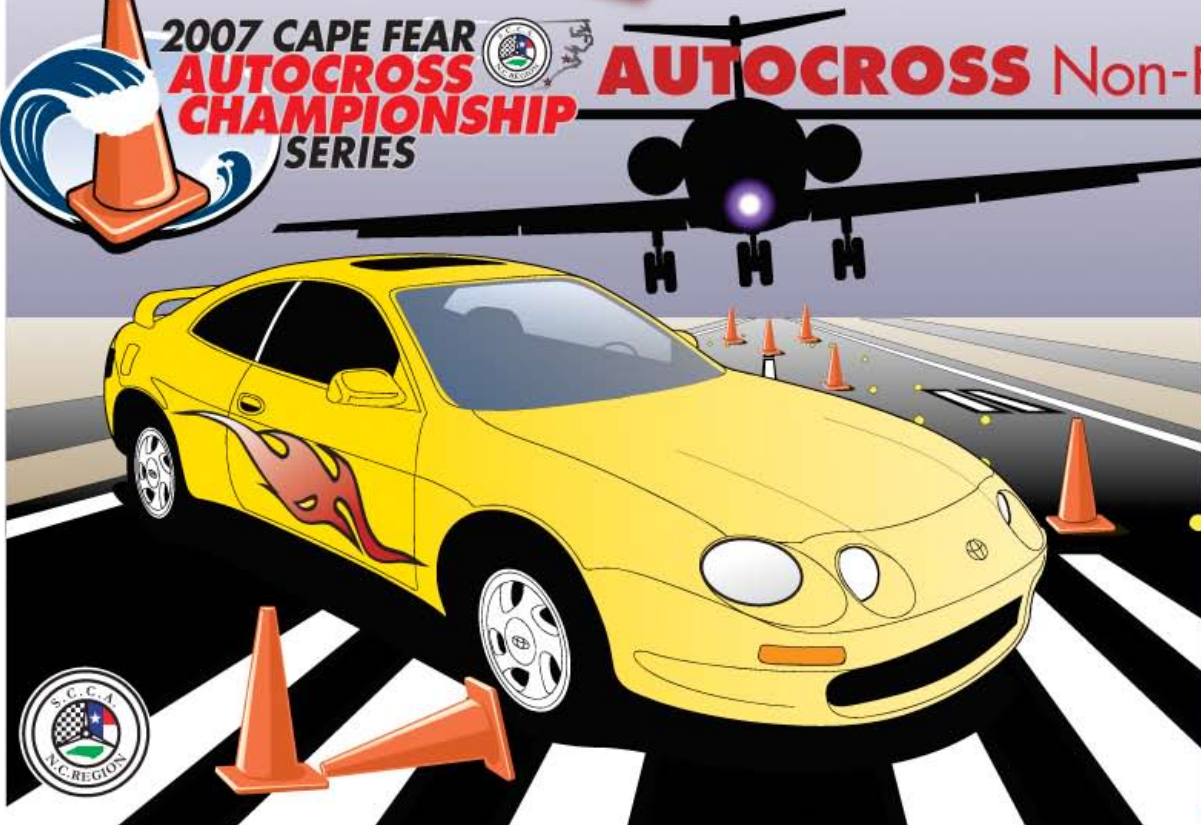

Present Mark Senior, RE, Anna Crissman, Buddy Matthews, Jerry Pell, Ginny Condrey, Ed Wentz, Heather Powers, Joedy Pennington, Rex Deffenbaugh, Richard Franklin, Blair Stitt, Bruce Dover, and Sara Snider, via telephone.

1. The meeting was called to order at 7:37 P.M. by Mark Senior, RE.
2. Motion (Stitt/Wentz) to approve the Minutes of the February 21, 2007 Board of Directors meeting; Passed.
3. The RE recognized guests, Anna Crissman and Bruce Dover.

Reports:

1. Chapter Reports.

A. Cape Fear Chapter/SOLO Program: Richard Franklin, Chapter Coordinator, reported that 17 people attended the last Chapter meeting, at which meeting the recent SOLO event at UNCW was critiqued, which event had 75 entries, good weather and numerous spectators. Richard reports that event generated a profit of \$682. The next SOLO event is the Top Gun Challenge, scheduled for April 15th, which via pre-registration is fully registered. Said event will be held at the New River Air Station. The Cape Fear Chapter meeting also discussed the fee structure for the upcoming PDX/TT event, scheduled for Rockingham in April, including the \$50 entry fee discount available to workers at that event. Richard also advised as to the future SOLO event(s) scheduled for the Regional Jetport Global Transpark, in Kinston.

B. Triangle Chapter: Blair Stitt, Chapter Coordinator, reported 21 members attended the last Chapter meeting. Further, he reports that at the next meeting the Chapter will view a film highlighting an English track. The Triangle Chapter also discussed the upcoming PDX/TT event at Rockingham.

C. West Chapter: Ed Wentz, Chapter Coordinator, reported that 29 people attended the last Chapter meeting, which enjoyed a Power Point presentation by Dave Lumpkins, as to the scoring method used at our Rally events.

D. RE Report: The RE advises that the North Carolina Region will be working only one contract event at VIR in 2007, that being the fall GrandAm event at VIR. Previous contract events which the Region has traditionally worked at VIR will, in 2007, be handled by VIR's own corner workers.

2. Committee Reports.

A. Advertising: The Richmond County Daily Journal had a front page story and 2 color photographs, on its front page, highlighting the NCR's March Memories Race at Rockingham, which story appeared in the Sunday, March 11, 2007 edition. A copy of advertisement of the "Rush to the Rock", the PDX/TT event scheduled for April 21-22, 2007, is attached to these minutes.

B. Banquet Committee: Rex reports that there is no new information from the Banquet Committee, but he reminded the Board that if the banquet is moved to another city for 2008, that the Board will need to appoint some new members for the Committee, from the area of the relocated banquet, as the Raleigh members of the Committee have indicated that they would not be able to perform their functions for an out of town banquet.

C. Budget and Finance Committee: Sara Snider reports that the Committee will be providing a financial report as to the profit levels which need to be achieved, and the related race entry fees to be charged, for future races, which information would be applicable for race events in 2008. The Committee suggests raising entry fees at least \$15, \$10 of which is to cover increased costs of operation and \$5 is to cover the worker's fund and worker perks. Sara further reports that the CCPS entry fees will have to go up to cover increased costs of operations for this race group. The Committee is also recommending a reduction of the fee paid by the Region to the CCPS points fund, to the same level as the fee paid to the ECR points fund, per race entry, which would be a reduction from the \$75 per car fee, formerly paid to CCPS points fund, per race entry.

D. Charities Committee: The Committee anticipates using the same charities as last year, with one exception.

E. Competition Board: It was reported that the Competition Board had a meeting at Rockingham at the March race event, regarding the upcoming SARRC/MARRS event at VIR, and the 13 Hour Enduro Race at VIR. The Comp. Board reported as to one of its member's decision to leave early from the last Comp. Board meeting. Further, the Comp. Board completed the Supplements for the May, 2007 SARRC/MARRS event and resolved most of the issues regarding the Supps. for the 13-Hour Enduro event in the fall of 2007. The Comp. Board discussed the issue of the 55 gallon fuel drum rule on pit road and the matter of a second fire truck being placed on pit road during the 13 Hour Enduro event in October, 2007. Further, the 90 second minimum refueling rule was discussed and the Comp. Board is presently seeking feedback from the 13 Hour forum, as to allowing the use of dry break refueling systems; no changes, however, were made in the fuel capacity rule, as now provided by Class rules. It was announced that the BMW Club will rent the Region's scales at VIR on

Saturday, April 14th, at a rental rate of \$300 per day, with the Region providing a scale operator as part of the rental arrangement.

F. PDX/TT (Time Trial): The Board was advised of the use of a photo eye for timing the next TT event. The Board also discussed the possibility of having 2 CCPS races (Saturday and Sunday), held in conjunction with the PDX event now scheduled for Rockingham on September 8 and 9, 2007. The Board considered the issues this potential match-up could cause at a PDX event.

3. Finance

A. Treasurer's Report: Sara presented the P&L Statement for the period February 22 through March 16, 2007, a copy of which is attached to these Minutes. It was reported that the Rockingham March Memories race will be about a break even event, or show a small loss.

Old Business:

1. Workers' Perks. The NCR Board of Directors discussed holding a drawing for the workers to receive leftover worker gifts from prior race events. The Board further discussed providing gifts for the Specialty Chiefs. Mark suggested that Janet obtain a proposal for a Specialty Chief jacket, or that some payment be made towards a Specialty Chief recognition gift. Motion (Snider/Pennington) for Janet to investigate the cost of a Specialty Chief jacket; Passed.

2. Computer purchase request. The Board discussed a request that new laptop computers be obtained for timing and scoring, and for registration. It was reported that there is a need for a minimum of two new computers, with the current computers (two Dell laptops) to be used as backup for timing and scoring and for registration. It was also discussed that the I Card System needs a laptop computer and the Board of Directors discussed the parameters (capacities) for these needed computers. Motion (Deffenbaugh/Snider) to buy two new laptop computers, for timing and scoring and for registration, at a cost not to exceed \$1,200 each; Passed.

3. Operations Manual. Ginny inquired of the Board as to the final version of the Operations Manual. Ginny will forward a copy of the last draft of the manual to the members of the Board for their review, with the view that the Board will finalize the manual, which was last presented in 2005.

4. Florida Region Proposal. Mark reports that there is a proposal being circulated from the Florida Region in support of the establishment of a new national endurance series, which proposal would include our Region's 13 Hour Enduro event. The RE discussed some of the practical factors, and some objectives that the proposed enduro series is looking to create, and advised that the proposal is seeking seed money to start the series. Motion (Snider/Pell) to table further discussion of the Florida Region's proposal as to a new national endurance series; Passed.

New Business:

1. South Carolina Region request. The RE reports that the South Carolina Region has requested that the North Carolina Region give its consent to the South Carolina Region using the Rockingham track in 2008 for a Double SARRC, at the end of March, 2008. It was suggested that the NC Region should wait until it has its 2008 VIR dates secured, before formally responding to said request from the South Carolina Region. The consensus of the Board is to advise the South Carolina Region as to the present position of the North Carolina Region's Board, as to their request.


2. Entry fees for SARRC/MARRS. It was announced that the entry fee for the 2007 SARRC/MARRS event is \$200 for a single entry and \$375 for a double entry. The entry forms, or related documents, will disclose to the racers the approximate amount of each entry fee that goes towards the cost of workers' credits, perks and benefits.

3. Emergency light replacement for pace car. Motion (Snider/Deffenbaugh) to have the Region's equipment manager purchase a new light bar for the pace car, after first conferring with Ed Wentz to obtain his approval as to the type of pace car light bar to buy; Passed.

4. Board of Directors Meeting location. The Board discussed a potential new place to hold its Board of Directors meeting, each month, a new location about 13 miles further east from the present location in Hillsborough. The Board indicated the need to first determine, as to the new place, three issues: 1) phone line (conference call) availability, 2) restaurant closing time, and 3) potential for our meeting being bumped by a larger group.

5. Phone cards. The Board of Directors authorized the issuing of new long distance phone cards to the Board Members, for those who desire to have their expired phone cards replaced.

6. Rick Cochran Award. The Board discussed, and approved, the Region's giving an annual award in honor of Rick Cochran's memory, for a five year period, beginning with the initial award given in 2006; Passed.

Motion (Pell/Matthews) to adjourn the meeting at 10:00 P.M.; Passed.

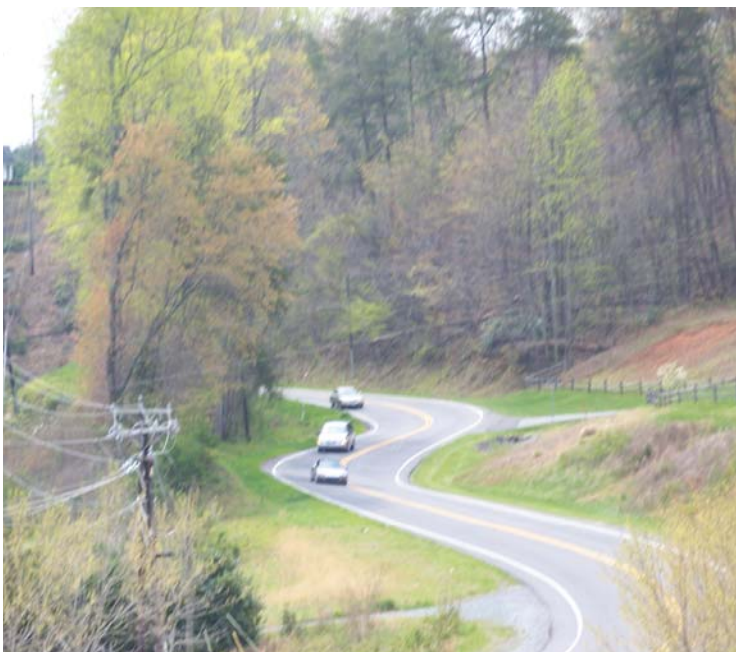
A TSD rally is a Time-Speed-Distance event, where the rallymaster lays out a course and sets average speeds to maintain during various portions. Checkpoints are set up along the way to check how well you are able to follow the instructions. A touring rally means there are no course following traps. This rally started in Greensboro and was about 100 miles long, traversing the mountainous area around Hanging Rock State Park. What great roads, especially trying to average 40 mph! There were 12 checkpoints to determine how well each contestant was doing. The object was to reach each checkpoint as close to the perfect time as possible (only you didn't

know where the checkpoints were going to be), with the winner having the lowest total score.

This was a joint event, sponsored by SCCA and PCA, and is one that Dave hopes to put on annually. It takes a lot of time and gasoline to set up a good event, as well as several hours of computer time to calculate the times for each checkpoint and print out all the instructions. Dave and Fran are to be congratulated on a fine outing. 🏁

'Last Open Road' Auto Olympics added to VIR Gold Cup Weekend

Danville, Va. (Feb. 5) – The Heacock Classic Gold Cup Historic Races at VIRginia International Raceway, scheduled for June 8-10, will include a new feature this year. VIR is collaborating with popular motorsports author Burt (BS) Levy to create 'The Last Open Road' Auto Olympics, a four-part competition for enthusiasts.

Levy, noted journalist and the author of the cult-classic racing novels *The Last Open Road*, *Montezuma's Ferrari*, *The Fabulous Trashwagon* and *Toly's Ghost*, created the concept in order to get fans more involved in a vintage-racing weekend.

"It's important for owners of sports and classic cars to use and enjoy their cars, and we wanted to find a way to get the spectators more involved," Levy explained. "Give them more of an opportunity to participate instead of just watch. And I think we've come up with something pretty special."

The four segments of the "Last Open Road" Auto Olympics will include a car show, an autocross on VIR's 1.1-mile Patriot Course, track touring on the 3.27-mile Full Course and a 90-minute road rally on the country roads surrounding VIR. The scoring will favor participation over finishing position (although results will count), and trophies sponsored by VIR and *Classic Motorsports* magazine will be presented for individual, club and marquee champions at the end of the weekend.

The car show segment will be in conjunction with the existing Gold Cup Car Show, which is organized by the

Corsa Rossa organization from North Carolina.

"This year we'd like to expand the car show entry to include (in their own classes, of course) more older, classic sports cars, some American classics and muscle cars, more modern sports and GT cars like Boxsters, GTIs and Miatas and maybe even a few Drive-In Cruisers and Street Rods," Levy said. "We'd like to invite more clubs to participate, too."

The autocross portion of the event will use a course set up on the Patriot Course. Participants will sign up for a time in advance, rather than having to wait in long lines to get on the track. The track touring segment will be run on the full 3.27-mile Full Course behind a pace car, during breaks in the scheduled vintage racing action for lunch. The road rally will be a 90-minute "do-it-yourself/start-any-time-you-want" event, with participants punching in and out on a time clock and following a prescribed course on the winding country roads in Southern Virginia and northern North Carolina.

"By the way," Levy added, "I'll be the rallymaster, and I guarantee something really different and enjoyable. And maybe a little diabolical, too!"

A single entry fee of \$125 (including two three-day spectator passes, three runs on the autocross course, rally entry, car show entry, lunchtime track touring and four lunch tickets at the Pagoda restaurant) will be available, along with special discounts for early registration (\$10 off if registered before April 1) and multi-car "club entries" of six or more cars (\$100 per car).

"We're excited to be working with Burt Levy on 'The Last Open Road' Auto Olympics," said VIR general manager Josh Lief. "Burt's devilish sense of humor should lend itself perfectly to a fun event for our fans that will enable them to be more intimately involved with the Heacock Classic Gold Cup Historic Races and compete for their own trophies. We're really looking forward to the weekend."

Advance three-day Super Tickets for the Heacock Classic Gold Cup Historic Races will be priced at \$30. At the gate, three-day Super Tickets will be priced at \$40. Also, single-day tickets will be available for Friday (\$10, gate only), Saturday (\$15 advance/\$20 gate) and Sunday (\$15 advance/\$20 gate). VIR is a family-friendly facility, where children 12 and under are admitted free with a paying adult. Spectator camping is available. Call 434-822-7700 x300 or x116 for advance ticket sales. 🏁

18. TROUBLE LIGHT: The home builder's own tanning booth. Sometimes called drop light, it is a good source of vitamin D, "the sunshine vitamin," which is not otherwise found under cars at night. Health benefits aside, its main purpose is to consume 40-watt light bulbs at about the same rate that 105-mm howitzer shells might be used during, say, the first few hours of the Battle of the Bulge. More often dark than light, its name is somewhat misleading.

19. PHILLIPS SCREWDRIVER: Normally used to stab the lids of old-style paper-and-tin oil cans and squirt oil on your shirt; can also be used, as the name implies, to round off the interiors of Phillips screw heads.

20. AIR COMPRESSOR: A machine that takes energy produced in a coal-burning power plant 200 miles away and transforms it into compressed air that travels by hose to a Pneumatic impact wrench that grips rusty bolts last tightened 70 years ago by someone at GM, and rounds them off or twists them off.

21. PRY BAR: A tool used to crumple the metal surrounding that clip or bracket you needed to remove in order to replace a 50 cent part.

22. HOSE CUTTER: A tool used to cut hoses 1/2 inch too short.

23. HAMMER: Originally employed as a weapon of war, the hammer nowadays is used as a kind of divining rod to locate expensive parts not far from the object you were trying to hit.

24. MECHANIC'S KNIFE: Used to open and slice through the contents of cardboard cartons delivered to your front door; works particularly well on boxes containing upholstered items, chrome-plated metal, plastic parts and especially on the other hand not holding the knife. 🏁
